Welcome / Introductions / Call to Order Interim Chair Foster

Officer Elections (Committee Members)

Peter Breton, Community Engagement Coordinator

Adam Powell nominates Stephen Foster for the position of Chair, and he accepts. Stephen Foster is elected as Chair unanimously.

Stephen Foster nominates Lauren Taylor for the position of Vice-Chair, and he accepts. Lauren Taylor is elected as Vice-Chair unanimously.

# **Initial FY2024 Budget Review**

Kevin Conlan, Deputy CFO

**Kevin Conlan** overviews the initial budget for FY2024, including investments in a Demand Response operations and maintenance facility, electric bus purchases, and Project Connect projects.

**Leslie York** asks about how the electric bus purchasing will work. **Kevin Conlan** says CapMetro is buying vehicles as replacements for decommissioned diesel buses, and so the electric buses will come in staggered.

**Leslie York** asks how CapMetro will charge the buses, and **Kevin Conlan** explains that there will be charging onroute as well as at various CapMetro facilities.

Adam Powell asks about how raises are calculated. Kevin Conlan says that historically, CapMetro has extended 3% cost of living adjustments to all their employees, along with performance-based raises; however, last year, the adjustment was 5%. He adds that CapMetro is currently performing a salary study for individual positions as well as an overall assessment of the current positions.

Adam Powell asks when requesting new positions is allowed, and Kevin Conlan explains that most requests are budget-timed, but some are ad-hoc.

**Stephen Foster** asks about the infrastructure investment for non-bus vehicles. **Kevin Conlan** explains CapMetro is starting to explore electric vehicles for paratransit and non-revenue fleet needs.

# **Community Intervention Program Update**

**Holly Winge** updates the committee on the Community Intervention Program, including introducing a new team member, key performance indicators, and new developments.

**Kathryn Kalinowski** mentions that that she's heard lots of positive feedback about CapMetro's work in public safety, especially around Community Intervention Specialists and Public Safety Ambassadors.

**Eric Robins** updates the committee on key developments of the transit police department, such as Interlocal Agreements/Memorandums of Understanding, facilities projects, and staffing.
